Rules:

1. An entry fee of €50.00 per team to be paid before play. One Team per Club. The maximum handicap is 17.4 (Index) pairing and order of play must be in order of course handicap (whole number not index). **The team must consist of two pairs with a maximum handicap index, on the day, of 10.4 and three pairs with a handicap index, on the day of between 10.5 & 17.4. Where Players have a handicap index which exceeds the stipulated maximum in either of the two bands, they must adopt the maximum handicap index in the range for the purpose of shot calculation.**
2. League to be on a knockout basis (home and away). The lowest player reverts to scratch and concedes strokes to the other three players based on Nine Tenths (75%) of the difference between the course handicaps on the day of the fixture. As shot calculations will be determined by course handicap player's course handicaps may exceed 17 for the purpose of shot calculation.
3. In the event of a tie in matches, holes-up count. (i.e. It is not necessary to complete holes, i.e. if a match is won 5 & 4, the match result is 5 holes up).
4. In the event of a tie in holes up the tie will be decided by sudden death by the top match i.e. the four lowest handicaps.
5. The dates must be adhered to, and the home team (top named team) is responsible for arranging the match. In the event of difficulty, the Convenor should be contacted.
6. Results must be reported to the Convenor by the winning team within two days. Captains to email team sheets with players' handicaps to dcgcommittee@gmail.com as agreed at AGM
7. The convenor shall be informed of any dispute about dates well before the closing date for the match. The decision of the Committee to be final in the event of any dispute.
8. Captains of teams are to contact one and other and arrange dates for both matches as soon as possible. The top named team is responsible for making the first approach. must be reported to the Convenor by the winning team within two days. The decision of the Committee to be final in the event of any dispute.
9. Captains of teams are to contact one and other and arrange dates for both matches as soon as possible.
